Title of Resolution

A Resolution Rebuking Senator John Thune for his Performance as US Senate Majority Leader, and Censuring Him Until the SAVE America Act becomes Law

Summary of Resolution

The SAVE America Act languishes in Congress, in spite of its overwhelming national support and importance for national security. While there are many ways in which John Thune's performance as Senate Majority Leader have been found wanting, his failure in regards to the SAVE America Act is his most glaring, and can not be ignored. It is for this reason that we, the elected representatives of the South Dakota Republican Party, find it regretfully necessary to censure South Dakota Senator and US Senate Majority Leader John Randolph Thune until such time as the SAVE America Act is officially signed into law.

Whereas Statements

WHEREAS an overwhelming majority of citizens from not just South Dakota, but the entire United States of America, support the passage of the SAVE America Act;

WHEREAS the state government of South Dakota has passed its own version of the SAVE America Act;

WHEREAS the necessity of the SAVE America Act has been demonstrated by rampant election fraud across the entire nation, most blatantly - but by no means limited to - California;
